ELSEWEDY INDUSTRIES TANZANIA LIMITED (“The Company”) a registered company with registration number 141263242, Certificate of Incentive No. 202012226, Tin number 141-263-242 and Business License no 000001534 for manufacturing of electrical Appliances hereby gives notice of changes in ownership and name.

That SADEK AHMED SADEK EL SEWEDY being former owner of 1 share in the company sold his share to GENERAL MOTORS INVESTMENTS LIMITED of P.O.Box 16541, Plot 14, Vingunguti Industrial Area, Dar es Salaam, Tanzania and EL SEWEDY CONSTRUCTION INDUSTRIES being former owner of 99 shares in the company sold her shares to SIMBA PIPE INDUSTRIES LIMITED of P.O.Box 46259, Plot 68-70, Migeyo Road, Chang’ombe Industrial Area, Dar es Salaam, Tanzania respectively.

That the Company holds a derivative title under TIC with title number DSMT1010393 on Plot No. P6549 Block “X” Kigamboni Kisarawe II with incentives in manufacture electrical appliances project, and that GENERAL MOTORS INVESTMENTS LIMITED and SIMBA PIPE INDUSTRIES LIMITED will continue with the investment project as provided in the certificate of incentive.

That GENERAL MOTORS INVESTMENTS LIMITED and SIMBA PIPE INDUSTRIES LIMITED as the current shareholders and controllers of the company have changed the name of the company to SIMPA LIGHT INDUSTRIES LIMITED.

That from the above stated information, the Company is giving notice of the changes pursuant to section 19 (7) (a) and (b) of the Tanzania Investment Act, Act No. 10 of 2022.



Moreover, the said GENERAL MOTORS INVESTMENTS LIMITED and SIMBA PIPE INDUSTRIES LIMITED are both local owned companies as per attached BRELA SEARCH results and also holders of certificate of incentives as attached. For that reason, the company ceases to be a foreign company as its current shareholders are fully owned by Tanzanian Citizens with right to a ranted right of occupancy under section 19(1)(a) of the Land Act [CAP 113 RE 2019]. It is therefore the humble request of the company that the derivative title with title number DSMT1010393 on Plot No. P6549 Block "X" Kigamboni Kisarawe II may be changed to a granted right of occupancy in favour of the company.
