

## LEASE AGREEMENT

**THIS LEASE AGREEMENT** is made this 01..... day of JANUARY 2024

### BY and BETWEEN

**SAMWELI DIMISIMALI LUKWANDALI** of Saeni kibaha -Pwani (hereinafter referred to as "the **Lessor**" which expression shall, where the context so admits include her assigns and or successors in title) of the one part;

### AND

**ZHONGTENG CONSTRUCTION MATERIAL COMPANY LIMITED Of P.O.BOX 32080** Dar es Salaam (herein referred as the **Lessee** which expression shall, where the context so admits include his assigns and or successors in title) of the other part;

**WHEREAS** the **Lessor** being an owner of the land the subject matter of this Agreement situated at in the District of KIBAHA at PWANI SAENI PLOT NO 6,BLOCK NO J . Tanzania, is willingly to lease the said land to the lessee **AND WHEREAS** the **Lessee** is willing and desirous to lease the said property from the Lessor on terms and conditions stipulated hereunder;

The contracting parties, whose names and addresses have been indicated herein above, have agreed as follows:-

#### **Lease Term**

1. That this lease agreement will be for a term of 12 Months stating from 01..... Day of JANUARY 2024 to the 01.....day of DECEMBER 2027, renewable and or terminating at the option of both parties subject to 1 month notice prior to the expiry of the lease term.

#### **Lease Purpose**

2. The lease term provided herein for the above described property shall be for office purposes and things incidental thereto.

#### **Rent and Mode of Payment**

3. The rent for the said premises shall be the sum of TSHs Three Hundred Thousands (TSHs 300,000/=) only per month, which is 10,800,000 for three years.

**THE LESSEE HEREBY COVENANTS** with the Lessor as follows:

- a) Not assign the whole or any part of the lease property without the prior written consent of the **Lessor**.
- b) Permit the **Lessor** or persons designated by her at all reasonable times to enter the leased premises, with prior notice of at least 24 hours and with the consent of the **Lessee**, for the purpose of viewing the conditions of the demised premises.

- c) Pay and discharge all utilities such as electricity bills, water bills, telephone bills, security and any other utility directly consumed by the Lessee and the receipts shall be kept for records purposes.
- d) To maintain the leased property in a clean and sanitary condition and organized all the times.
- e) Use the premises for office purposes and any other activities related thereto.

**THE LESSOR COVENANTS** with the **Lessee** as follows:-


- a). To carry out all necessary major repairs and maintenance work to the lease premises (beyond the minor repair and maintenance) and ensure that the facilities remain in good working condition at all times to the full satisfaction of the **Lessee**.
- b). That the **Lessee** shall enjoy the facilities of the leased premises without any interference from the **Lessor**, his family members or his workers and/or agents.

**PROVIDED ALWAYS AND** is hereby reserved agreed and declared as follows;

- i. The monthly rent hereby reserved is liable to be increased or decreased as the case may be by the Lessor giving a notice of 3 months in writing to the Lessee prior to the end of the contract.
- 4. The contracting parties have executed this Lease Agreement on date and year hereinafter appearing.




