MEMORANDUM OF ASSOCIATION

OF

GULLED MARKETLINK LIMITED

1. The name of the company "GULLED MARKETLINK LIMITED"
2. The Registered office of the Company will be situated in Tanzania.
3. The Objects for which the Company is established is:
 - a. To establish and operate a wholesale and retail business company specializing on non-specialized fast moving consumer goods.
 - b. To carry on the business of consumer-packaged goods in wholesale and or retail.
 - c. To manufacture produce and sell household goods like foods, consumables, personal care, toiletries, oils and all related goods.
 - d. To carry on the business as suppliers of Food, Home Care, Personal Care, and Refreshments.
 - e. To manufacture, import and export of fast-moving consumer goods such as but not limited to soaps, shampoos, skin care, detergents, toothpaste, cosmetics, deodorants, tea, coffee, packaged foods, ice cream, and water purifiers.
 - f. To provide the consumers with standard global products to the consumer in Tanzania.
 - g. To specialize in the production and distribution of the products like personal care, household, health care, and veterinary products which include but not limited to toothpastes, toothbrushes, soaps, detergents.
 - h. To carry on the business of distribution of foodstuffs and all supermarket goods in wholesale and retail.
 - i. To carry on the business as importing and selling of all kinds of all kinds of foodstuffs and related goods and to carry on the business as wholesalers and retailers, distributors of all kinds of foodstuffs.
 - j. To market, distribute, import and export foodstuffs and also market food products directly to end users.

- k. To source, market, advertise, promote and distribute supermarket foodstuffs in the country.
- l. To carry on the business as food manufacturers and processors and to buy, sell, manufacture, compound, prepare and deal in all kinds of grains and foodstuffs.
- m. To engage and or otherwise carry on the business as general suppliers, general merchants, traders and suppliers of all kinds of foodstuffs and food products, supplier of all kinds of agricultural products, industrial products and food processors.
- n. To import machinery and equipment, raw materials, or any related goods for production of company business.
- o. To Import vehicles to be used for the company's business.
- p. To carry on the business of management of all kinds of property management, real estate and any related works thereto.
- q. To provide real estate management consultancy in Tanzania.
- r. To carry on the business in relation to real estate and property development in the country.
- s. To erect and construct houses, flats and mansions for rent of any tenure or interest for real estate management in Tanzania.
- t. To carry on the business of Petroleum products which includes but not limited to transportation fuels, fuel oils for heating and electricity generation, asphalt and road oil, and feedstocks for making the chemicals, plastics, and synthetic materials that are in nearly everything.
- u. To carry on the business of petroleum trading specializing in sales, distribution and storage of petroleum products.
- v. To build petrol stations within the country and carry on the business of selling petrol and diesel and related goods.
- w. To carry on the logistics on petroleum, arrangement of storage of petroleum, and to conduct feasibility studies of petroleum business on different aspects.
- x. To construct, erect, equip and carry on the business of petrol station with all usual or convenient buildings, petrol and oil pumps, plants, machinery, articles and things which may be required for purpose of

the said business or commonly supplied or dealt with by persons engaged in such business.

- y. To carry on the business of retail of lubricants, petroleum oil in the country.
- z. To carry on the business of Fuel Transportation and Petroleum Products marketing company in Tanzania.
- aa. To own and trucks, tippers and heavy-duty vehicles for transportation business in Tanzania.
- bb. To carry on the business of transport contractors, road haulage contractors and to own hire and operate heavy duty vehicles and heavy duty machinery together with trucks, lorries and trailers.
- cc. To carry on all or any of the business of transport, carriage and haulage contractors, owners and charter of road vehicles and carriers of goods by road and to establish, acquire, maintain and operate transport service of every description both public and private and all services ancillary thereto and for such purposes or as independent undertakings to purchase, take in exchange, charter, hire, build, contract or otherwise acquire and to own, operate, work, manage, maintain, repair, service and deal with and in road vehicles and vessels of every supplies therefore and to conduct any such business within the country.
- dd. To advance, deposit or lend money, securities, and property, to, or with such persons and on such terms as may seem expedient, to discount, buy, sell, and deal in bills, notes, warrants, coupons, and other negotiable or transferable securities or documents.
- ee. To guarantee or become liable for the payment of money or for the performance of any obligations, and generally, to transact all kinds of guarantee.
- ff. To subscribe for conditionally or unconditionally, to underwrite, issue on commissions or otherwise, take, hold, deal in, and convert, stocks, shares, and securities of all kinds, and to enter into partnership, or into any arrangement for sharing profits, union of interest, reciprocal concessions or co-operation with any person, partnership or company, and to promote, and aid in promoting, constitute, form or organize any company, syndicate or partnership of any kind, for the purpose of acquiring and undertaking any property and liabilities of this Company, or of advancing, directly or indirectly, the objects thereof, or for any other purpose which the company may think expedient.
- gg. To receive money on deposit or loan and borrow or raise money in such manner as the Company shall think fit, and in particular by the

issue of debentures or debenture stock (perpetual or otherwise) and secure the payment of any money borrowed, raised or owing by mortgage, charged or lien upon all or any of the property or assets of the Company (both present and future). Including its uncalled capital, and also by similar mortgage, charge or lien to secure and guarantee the performance by the Company or any other person or company as the case may be.



hh. To draw, make, accept, indorse, discount, execute, and issue promissory notes, bills of exchange, bills of lading, warrant, debentures, and other negotiable or transferable instruments.

That the meaning of any general word or words in any paragraph of this clause shall not be restricted by being construed ejusdem generis with any particular word or words in the same paragraph.

4. The Liability of the Members is Limited.
5. The Authorized Share Capital of the Company is Tanzanian Shillings Ten Billion 10,000,000,000/= divided into 1,000,000 shares of Shillings Ten Thousand 10,000/= each.


The Company shall have powers to increase its capital and to divide the shares in its capital for the time being into several classes of stock or shares and to attach thereto respectively such preferential, deferred or special rights, privileges, or conditions as may be determined by or in accordance with the Articles of Association of the Company.

We, the several persons whose names and addresses are subscribed, are desirous of being formed into a company, in pursuance of this Memorandum of Association, and we respectively agree to take the number of shares in the capital of the Company set opposite our respective names.
