## 10.0 Benefits As Resulted By This Incentives

The main benefit the company got is on tax relief. By being granted a certificate of incentives, the company was relieved from Import Duties by 75% from its registered expected imports for the period of past 3 years. This is equivalent to more than USD 275,000 tax relief from the purchased trucks.
