RE: APPLICATION FOR CERTIFICATE OF INCENTIVES FOR PROPOSED
INVESTMENT IN SETTING UP POULTRY FEED MILL

We are pleased to submit our application for Certificate of Incentives for the proposed investment in setting up a Poultry Feed Mill, which is aimed at expanding its poultry activities into feed manufacturing focused on participating and contributing to the growth of the commercial poultry sector in Tanzania and Sub-Saharan Africa. Currently Irvine's Tanzania purchases both broiler and breeder feeds from toll manufacturers. This comes with various challenges including additional cost, inadequate capacity as well as lack of direct control over feed quality and the procurement of raw materials. As a result of these challenges, the company's growth is constrained. With the expansion of its production and sales of day-old chicks, having adequate feed for both breeders and broilers will be key.

The proposed poultry feed mill is expected to be located at Zinga, Bagamoyo District, Coastal Region, Tanzania.

With the feed mill in place, the company will be able to save on the margin currently paid to the toll manufacturer of up to US\$42 per ton of feed (at least US\$850,000 for the FY2024 volumes). In addition to having a guaranteed supply for its breeder farm needs, the company will be able to expand on its current broiler feed sales and even be able to venture into other ranges of feed such as layer and pig feeds.
