- I. The name of the company is "NASHERA LIMITED"
- II. The registered office of the company will situate in Tanzania.
- III. The objectives for which the Company is established are:
 - (a) To invest in and carry on the business of hotels, restaurants, cafes, motels, holiday camps, apartment houses, cottages and casinos.
 - (b) To carry on the business or businesses of construction, arranging, providing and reserving hotel accommodation and organizing and supplying guides and conducting tours, trips and excursions of all kinds and the business or businesses as proprietors, organizers, operators, owners, and managers of guest houses, hotels, motels, lodges, inns, caravans, caravan sites, wildlife lodges, camps and camping sites and motorway and roadside restaurants and service areas, holiday camps, fair grounds, and providing any other accommodation or assistance to travelers and others; and owning, hiring and otherwise dealing in every way with every kind of article, equipment, appliance and product required or used in connection with any such business and generally providing services.
 - (c) To carry on business of tourism and safari operators, travel agents, and hotels owners, and promote and facilitate accommodation and traveling, entertainment, recreation, amusement, sports, whether indoor or outdoor, including funfairs, cinematography, audio-video, (including television) performances, stage and variety shows, pyrotechnic, aerial, and spectacular displays, dancing, skating, circuses, and other forms and types of the like.
 - (d) To carry on the business of professional hunting, game ranching, and to organize and prepare hunting safaris, and expeditions, tourist and sport hunting, photographic tours and to set up, maintain and operate animal, fish, and horticultural farms of all nature and types.
 - (e) To carry on the business of manufacturers of and dealers in paper, cardboard, containers, packing materials, printing, drawing and writing materials and requisites, pens, inks, greeting cards, diaries and stationery generally.
