AND IT IS HEREBY DECLARED that the word "Company" in this clause except where used in reference to this company shall persons whether incorporated or not incorporated, whether domicile in Tanzania or elsewhere and that the objects set forth in any sub-clause of this clause, shall not be restrictively construed the widest interpretation shall be given there to and they shall not extend when the context expressively so required be in any way, limited to or restricted by reference to or inference from any others objects or object set forth in such clause or from the sub-clause or the object or objects therein specified, or the powers thereby conferred shall be deemed subsidiary auxiliary for the objects or powers mentioned in any other sub-clause, but the company shall have full power to exercise in any one or more of the said sub-clauses.
