

# **LEASE AGREEMENT**

*BETWEEN*

**NOEL SAMWEL KISIRI** of Kigamboni, Mwasonga street, in Kisarawe II, Dar es salaam region (hereinafter referred to as "**LESSOR**") which expression shall where the context so admits include heirs, successors and assignees in title and right.

*AND*

**MAZARO CLEAR SPRING INVESTMENT CO LIMITED** of P.O Box 13478, DAR ES SALAAM, TANZANIA (hereinafter referred to as "**LESSEE**") which expression shall where the context so admits include their heirs, successors and assignees in title and right.

**WHEREAS** the **LESSOR** is a lawful owner of the un-surveyed landed property situated at Kigamboni area Mwasonga street, in Kisarawe II Dar es salaam region, Tanzania (herein after referred to as the "**Property**").


