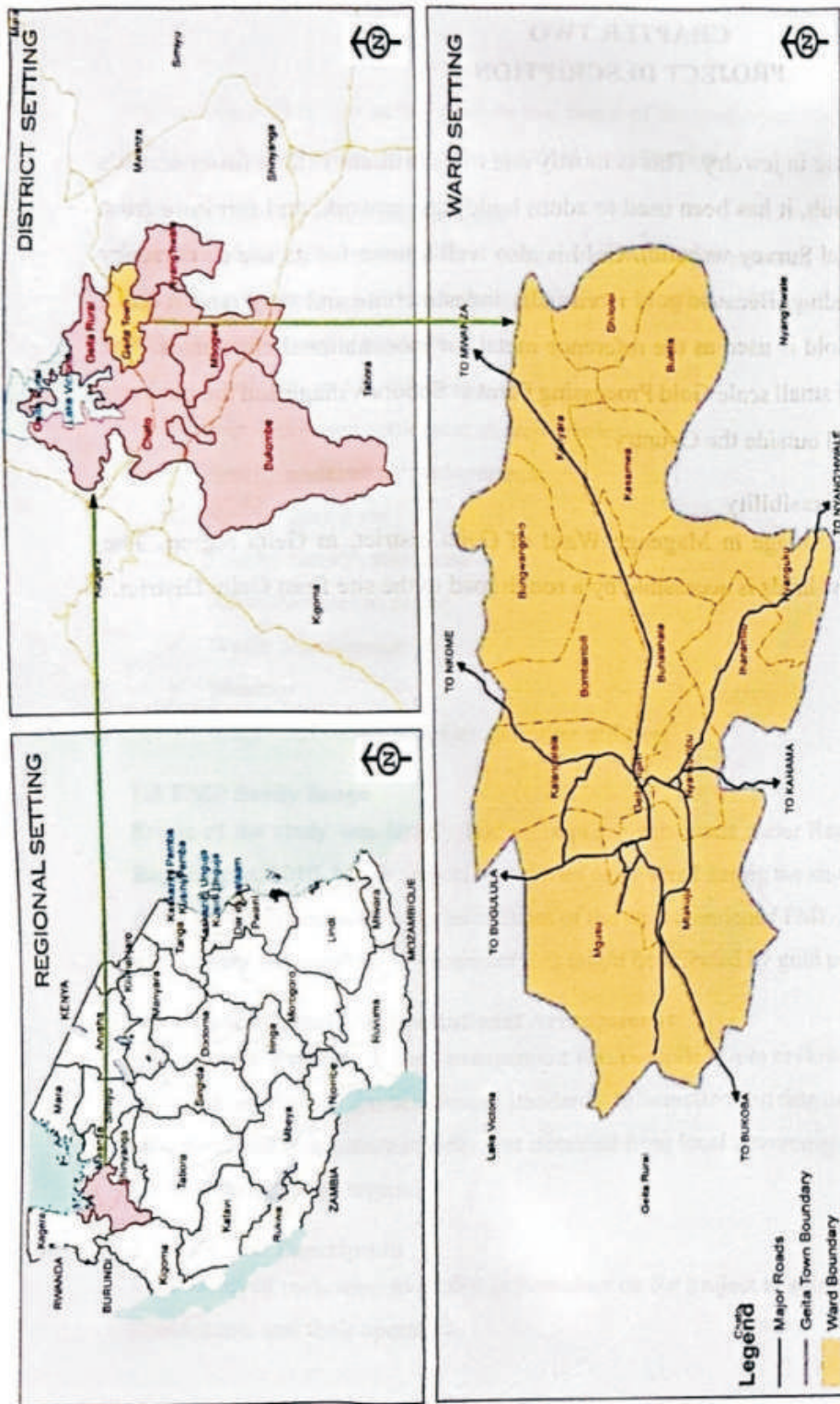


Figure 2: Project location ward level.
