MEMORANDUM OF ASSOCIATION

OF

AL ZAYTONA NETWORK COMPANY LIMITED

1. The name of the company "**AL ZAYTONA NETWORK COMPANY LIMITED**"
2. The Registered office of the Company will be situated in Tanzania.
3. The objects for which the Company is established are:
 - (a) To engage in or otherwise to carry on the business of providing health care services, own and running and hospitals, offering curative and preventive services, provide accommodation for treatment and care of all persons who by reason of any illness disease, disability, accident, or otherwise are in need of same and also to provide proper medical attendance nursing, food, medicine and drugs and all this and appliances of a medical, surgical, pharmaceutical, sanitary or other.
 - (b) To build, own and operate hospitals, dispensaries, diagnostics centers, dental clinics, maternity homes clinics, heat treatment centers and offices for lease or otherwise.
 - (c) To engage in and carry out the business of proprietors and manager of hospitals, dental clinics, dispensaries, maternity clinics, cafes, restaurant motels, health schools, apartment, housekeepers, refreshments and tea rooms, milk and snack bars, and to provide food and catering.
 - (d) To engage in and or otherwise carry on the business making medical surgical, oalapaedic and rehabilitation, Aid products, scientific medical supplies and professional medical service providers services, medical tools and apparatus, to carry on or otherwise engage in the business of manufacture, selling pharmaceuticals, medical equipment, laboratory equipment, organize market survey into the supply of medicines, equipment, surgical instruments and any type of equipment which may be used to enhance the foregoing objects, maintaining diagnostic laboratories, Diagnostic kits, medical service consultants all businesses and trades incidental, analogous, similar thereto, required to be or capable of being carried on in conjunction therewith.
 - (e) To carry on the business as importers, exporters, market and dealers in supplying surgical instruments appliances and of artificial limbs, eyes and other aids for the relief of defects of body or sight or hearing and to make and deal in all requisites for hospitals, patient and invalids.
 - (f) To carry on business as manufacturers, processors, refiners, manipulators, distributors, buyers, sellers, importers, exporters, and dealers in pharmaceuticals, medicinal, antibiotic, bacteriological and immunology preparation of all kinds and description.
 - (g) To carry out on the business of selling human medicines as wholesalers and retailers, to open pharmaceuticals stores in any part of the country, importing




at a rate not exceeding current bank rate on money lent, or reasonable and proper rent for premises demised or let by any member to the Company.

AND PROVIDED that nothing herein before contained shall prevent and payment to any company of which a member of the Board of Directors may be a member or for services rendered

4. The Liability of the Members is Limited.
5. The authorised share capital of the Company is Shillings **1150000000** divided into **100** shares of Shillings **115000000** each.

The Company shall have powers to increase its capital and to divide the shares in its capital for the time being into several classes of stock or shares and to attach thereto respectively such preferential, deferred or special rights, privileges, or conditions as may be determined by or in accordance with the Articles of Association of the Company
