Incentives No. 20227837**

Reference is made to your letter dated 28<sup>th</sup> May, 2024 as supported by a letter from Tanzania Investment Centre with Ref. CCA.188/234/TOUR/20227837/04 of 04<sup>th</sup> June, 2024 on the above captioned subject.

We hereby confirm and approve **Two-page** list of items herewith attached as deemed capital goods to establish and operate Tourist camp and Lodge with the certificate of incentives mentioned above. Furthermore, be informed that the imported Hotel equipment (Kitchen ware, television, Furniture's, linen and curtains, etc) are exempted from Import Duty by virtue of Para 21 of Part B of the Fifth Schedule to the East African Community Customs Management Act, 2004. Other deleted items are not eligible for exemption.

The approved deemed capital goods will be exempted from Import Duty to the tune of 75% of the Import Duty Payable.
