Subject: Request for Waiver for Construction Vehicle for Mobilization of Construction at Nyambogo

We are writing to formally request a waiver for the construction vehicle permit entry to our site in Nyambogo for mobilization purposes. We have attempted to apply for the necessary permits via the designated portal; however, our application was rejected due to the weight of one of our vehicles (Tractor – T751EKA)

We would like to emphasize that this vehicle will not cross any of the bridges (the contractor will bring it in via Nyasirori Ranger post to Kirawira using the old drift rather than the bridge to get over the Grumeti River), thus avoiding any structural challenges within the designated area. Our mobilization is critical for the timely commencement of our project, and we kindly seek your urgent approval for the period from 21st February 2025 to 20th May 2025. It is important that we get this tractor on site as it would be of assistance to navigate through muddy roads whilst the rain season approaches.
