MEMORANDUM

OF

MERU BOARDS LIMITED

1. The name of the Company shall be **MERU BOARDS LIMITED**.
2. The registered office of the Company will be situated on the mainland of the United Republic of Tanzania.
3. The objects for which the Company is established are: -
 - 3.1 To engage in the business of manufacturing, supplying and dealing in gypsum boards, particle boards, dried and grinded raw gypsum, drywall, gypsum wallboard, fiber reinforced gypsum panels, glass mat gypsum substrate, water- resistant gypsum backing board, gypsum lath, ceramic moulds, plaster voce, prefab panels and cornice, surgical and dental casts, blackboard chalk, gypsum made food additives and all other related products;
 - 3.2 To carry in Tanzania mainland the business of searching, prospecting, exploring, mining, drying, calcinations, recycling, processing in any other manner and to deal generally in gypsum and other related substances;
 - 3.3 To own, operate or otherwise deal in mines, deposits, reserves and to excavate, dig for, extract, quarry, unearth, supply, store, sap, prospect, explore, look for and search and trade in gypsum of all types and description, to market, buy, sell, stock, carry on business or otherwise

deal in all kinds of gypsum and all other related materials;

- 3.4 To engage in the business of manufacturing, supplying and dealing in dried and grinded raw gypsum, drywall, gypsum wallboard, fiber reinforced gypsum panels, glass mat gypsum substrate, water-resistant gypsum backing board, gypsum lath, ceramic moulds, plaster voce and cornice, surgical and dental casts, blackboard chalk, gypsum made food additives and all other related products;
- 3.5 To carry out business of making concrete transmission poles and other cement related items
- 3.6 To purchase, take on, lease or otherwise acquire mines, workings and mining grounds, lands and properties of every description and to purchase, take on, lease or otherwise acquire in exchange licenses, concessions and grants over any lands and mines, and to acquire gypsum mining rights easements, buildings, privileges, machinery and other effects whatsoever which may be required for any of the company's activities;
- 3.7 To carry on the business of importers of different types of machines and all equipment's, goods and items for carrying out the objectives of the Company in international trade;
- 3.8 To carry out, complete and engage in data acquisition, processing, interpretation and evaluation of all environmental, geological, hydrological and geophysical surveys, research and related operations, on-shore and off-shore for exploration, development and management of natural resources including but not limited to water, oil, gas and minerals and all other surveys, research and related operations for civil engineering including but not limited to dam-sites, road construction and foundation studies;
- 3.9 To carry on trade or business whatsoever which may seem to the company capable of being conveniently carried on by the company in connection with or as ancillary to its general businesses or any of the

above businesses or calculated directly or indirectly to enhance the value of any of the Company's property and rights for the time being;

- 3.10 To carry on business as general traders, importers, and exporters of all sorts of products and merchandise whether as whole seller or retailer or both. To operate and manage shopping centers for all sorts of merchandise and for those purposes to establish warehousing facilities, stores;
- 3.11 To carry on the business of project management consultants, financial and industrial consultants, business analysis and to undertake technical writing and the management or re-organization of any business, training of staffs, to act as advisers to any individual firm, organization, company, corporation public body, government department, agency or other authority in connection with all aspects of management, organization, stocktaking, planning, advertising, public relations, training, marketing and statistics;
- 3.12 to act as secretary, registrar, receiver, and treasurer for any company, cooperation or body, to provide technical assistance in connection with any trade, business, to provide data processing, computer, costing, accounting services and generally act as consultant and advisers;
- 3.13 To erect and construct houses, flats, offices, buildings or works of every description whether for the company or for any persons on any land of the company or upon any other lands or property, and to pull down, rebuild, enlarge, alter and improve existing houses, flats, offices buildings or works thereon, and to convert and use any such land into or for roads, squares, gardens, pleasure grounds and other conveniences, and generally to deal with and improve the property and investments of the company;
- 3.14 To sell, exchange, lease, let, mortgage, or otherwise dispose of the lands, houses, flats, offices, buildings and any business and other property of the company or any interest therein and to grant lease for the use or occupation of the same or any part thereof to grant to such members of

the company as may be selected by its directors leases relating to all or any part of the buildings or lands of the company or properties upon such terms and conditions as may be determined by the company from time to time;

- 3.15 To purchase, take on lease, or otherwise acquire, for the purposes of the Company, any estates, lands, buildings, easements or other interests in real estate and to sell, let on lease, or otherwise dispose of, or grants rights over any real property belonging to the company;
- 3.16 To let on lease or on hire the whole or any part of real and personal property of the company on such terms as the company shall determine;
- 3.17 To carry on the business of proprietors of clubs and other recreation rooms and refreshment rooms and to afford accommodation for meetings gatherings of all descriptions whether social, commercial or otherwise and to let upon lease or otherwise the whole or any part of the property of the Company for any of the above mentioned purposes or otherwise;
- 3.18 To purchase or otherwise acquire, erect, maintain, reconstruct and adapt any offices, workshops, mills, plants, machinery and other things found necessary or convenient for the purposes of the company;
- 3.19 To invest moneys of the company not immediately required in such manner, other than in the shares of the company as from time to time may be determined;
- 3.20 To acquire by subscription, purchase or otherwise, and to accept and take, hold and sell shares or stock, in any company or society or undertaking the objects of which shall either in whole or in part, be similar to those of this company, or such as may be likely to promote or advance the interest of the company;
- 3.21 To negotiate loans and finances locally and abroad for the purpose of promoting tour operation and hotel business and herein act as financial

advisors or agents of stockholders, suppliers and financiers. The said loans to be used by the company or its subsidiaries or any other company, association or person;

- 3.22 To transact agency business of all kinds and also act as agents' representatives and distributors for any person, firm, company or corporation;
- 3.23 To receive money on deposit and to lend and advance money to such persons or companies on such terms as the company may think expedient and to guarantee performance by the company of any obligation or liability it may undertake;
- 3.24 To borrow or raise money by the issue of debentures, debenture stock (perpetual or terminable), bonds, mortgages, or any other securities, founded or based upon all or any of the property and rights of the company, including its uncalled capital if any, or without any such security, and upon such terms as to priority or otherwise, as the company shall think fit;
- 3.25 To acquire by subscription, purchase or otherwise, and to accept and take, hold and sell, shares, or stock, in any company, society, or undertaking, the objects of which shall, either in whole or in part, be similar to those of this company, or such as may be likely to promote or advance the interest of this company;
- 3.26 To provide for the welfare of persons in the employment of the company or its predecessor business, and the wives, widows, and families of such persons, by grants of money, pension, or other payments, and by providing or subscribing towards places of instruction and recreation and hospitals, dispensaries, medical and other attendance and other assistance, as the company shall think fit and to form, subscribe to or otherwise aid benevolent, religious, scientific, national or other institutions or objects which shall have any moral or other claims to support or aid by the company by reason of the nature or the locality of its operations or otherwise;

3.27 To enter into and carry into effect any arrangement for joint working in business, or for sharing of profits, or for amalgamation, with any other company, or any partnership or person, carrying on business within the objects of this company;

3.28 To amalgamate or enter into partnership whether perpetual or terminable, for sharing profits, union of interest, joint adventure, reciprocal concessions of cooperation with any person, firm association, or group of persons carrying on or engaged in or about to carry on or about to carry on or engage in or (in the case of a company) formed to carry on or engage in any business or transaction within the objects of this company or any business transaction or cause of action which may be seem to the company capable of being conducted so as directly or indirectly to benefit the company or to prevent or minimize apprehended loss, damage or cost to the company or to such person, firm, society, association or group of persons and to purchase, subscribe for or otherwise acquire and hold shares (fully or partly paid up) or stock in or security of, or to lend money, to guarantee the contracts of subsidize or otherwise assist any such person, firm, society, association or group of persons, and to sell, hold, re-issue with or without guarantee or otherwise deal with such shares, stock or securities;

3.29 To do all or any of the matters hereby authorized in any part of the world either alone or in conjunction with, or as factors, trustees, or agents for any other companies or persons, or by or through any factors, trustees, or agents; and to do all such other things as may appear to be incidental or conduct to the attainment of the above objects or any of them;

3.30 to carry on any other business that may be deemed profitable to the Company; and

3.31 to do all such other things as may be considered incidental or conducive to the attainment of the above objects or any of them.

4. The liability of the members is **Limited**.

5. The authorized share capital of the Company at the date of registration of this Memorandum of Association is **Tanzania Shillings Ten Billion Only (TZS 10,000,000,000.00)** divided into **1,000,000** ordinary shares of **Tanzania Shillings Ten Thousand Only (TZS 10,000.00)** each with power for the Company to increase or reduce such capital and to divide the shares in the capital for the time being, whether original or increased, in different classes, and to attach thereto respectively any preferential, deferred, qualified or special rights, privileges or conditions and so that unless the conditions of issue shall otherwise expressly declare every issue of shares, whether preference or otherwise, or any such rights, privileges or conditions shall not be altered or modified except in accordance with the Articles or Association registered herewith.

ARTICLES OF ASSOCIATION

OF

MERU BOARDS LIMITED

1. The regulations in Part II Table "A" in the First Schedule to the Companies Act, No. 12 of 2002 shall not apply to the Company.
2. In these presents, if not inconsistent with the subject or context, the words standing in the first column of the table next hereinafter contained shall bear the meanings set opposite to them respectively in the second column thereof.

- 2.1 The expressions "**Debenture**" and "**Debenture holder**" shall include "**Debenture Stock**" and "**Debenture Stockholder**", and the expression "**Secretary**" shall include a temporary or assistant Secretary and any person appointed by the Directors to perform any of the duties of the Secretary.
- 2.2 Save as aforesaid any words or expressions defined in the Act shall, if not inconsistent with the subject or context, bear the same meaning in these presents.
- 2.3 The marginal notes are inserted for convenience only and shall not affect the construction of these presents.
- 2.4 Words importing the singular number only shall include the plural and the converse shall also apply.

2.5 Words importing males shall include females.

3 The Company is a private company and accordingly: -

- (a) the right to transfer shares is restricted in manner hereinafter prescribed.
- (b) the members of the company (exclusive of persons who are in the employment of the Company) is limited to fifty, PROVIDED THAT, where two or more persons hold one or more shares in the Company jointly, they shall, for the purpose of this Article, be treated as a single member;
- (c) any invitation to the public to subscribe for any shares or debentures of the company is prohibited;
- (d) the Company shall not have power to issue share warrants to bearer.

LOANS BY THE COMPANY

- 5 No part of the funds of the Company shall be employed in the purchase of or in loans upon the security of the Company's shares. The Company shall not, except as authorized by the Act, give any financial assistance for the purpose of or in connection with any purchase of share in the Company.

RIGHTS OF SHARE HOLDERS

- 6 Without prejudice to any special rights previously conferred on the holders of any shares or class of shares already issued (which special rights shall not be modified or abrogated except with such consent or sanction as is provided by article 7 below), any share in the Company (whether forming part of the original capital or not) may be issued with such preferred, deferred or other special rights, or such restrictions, whether in regard to dividend, return of capital, voting or otherwise, as the Company may from time to time by ordinary resolution determine, and subject to the provisions of the Act the Company may issue Preference Shares which are, or which at the option of the Company are to be, liable to be redeemed.

MODIFICATION OF RIGHTS

- 7 Whenever the capital of the Company is divided into different classes of shares, the special rights attached to any class may, subject to the provisions of the Act, be modified or abrogated, either with the consent in writing of the holders of three-fourths of the issued shares of the class, or with the sanction of a Special Resolution passed at a separate General Meeting of such holders (but not otherwise), and may be so modified or abrogated either whilst the Company is a going concern or during or in

contemplation of a winding up. To every such separate General Meeting all the provisions of these presents relating to General Meetings of the Company or to the proceedings thereat, shall *mutatis mutandis*, apply, except that the necessary quorum shall be two persons at least holding or representing by proxy one-half in nominal amount of the issued shares of the class (but so that if at any adjourned meeting of such holders a quorum as above defined is not present, those Members who are present shall be a quorum), and that the holders of shares of the class shall, on a poll, have one vote in respect of every shares of the class held by them respectively.

SHARES

- 8 Subject to the provisions of Article 38, unissued shares shall be at the disposal of the Directors, and they may allot, grant options over, or otherwise dispose of them to such persons, at such times, and on such terms as they think proper, but so that no shares shall be issued at a discount, except in accordance with the Act. Unissued shares at the disposal of Directors
- 9 In addition to all other powers of paying commissions, the Company (or the Directors on behalf of the Company) may exercise the powers of paying commissions conferred by the Act, provided that the rate per cent, or the amount of the commission paid or agreed to be paid, shall be disclosed in the manner required by the Act and the rate of the commission shall not exceed the rate of ten per cent (10%) of the price at which the shares in respect of which the commission is paid are issued or an amount equivalent thereto. The Company (or the Directors on behalf of the Company) may also on any issue of shares pay such brokerage as may be lawful. Power to pay commission and brokerage
- 10 Shares may be held in the Company in trust for beneficial owner.

CERTIFICATES

- 11 Every person whose name is entered as a Member in the Register of Members shall be entitled without payment to receive within two months after allotment or lodgment of transfer (or within such other period as the conditions of issue shall provide) one certificate for all his shares of any one class or several certificates each for one or more of his shares upon payment of such sum, as the Directors shall from time to time determine. Every certificate shall be issued under the Seal. The certificate shall specify the shares or securities to which it relates and the amount paid up thereon. Provided that the Company shall not be bound to register more than three persons as the joint holders of any shares (except in the case of executors of trustees of a deceased Member), and, in case of a share or shares held jointly by several persons, the Company shall not be bound to issue more than one certificate therefore, and delivery of a certificate for a share to one of several joint holders shall be sufficient delivery to all such holders. - 12 If a share certificate be worn out, defaced, lost or destroyed, it may be renewed on payment of such fee (if any) and on such terms (if any) as to evidence, indemnity and the payment of out-of-pocket expenses of the Company for investigating evidence, as the Directors think fit. Renewal of

LIEN

- 13 The Company shall have a first and paramount lien on every shares for all moneys (whether presently payable or not) called or payable at a fixed time in respect of such share; and the Company shall also have a first and paramount lien and charge on all shares (including fully paid shares) standing registered in the name of each Member (whether solely or jointly with others) for all the debts and liabilities of such Member or his estate to the Company and that whether the same shall have been incurred before or after notice to the Company of any equitable or other interest in any person other than such Member, and whether the period for the payment or discharge or the same shall have actually arrived or not and notwithstanding that the same are joint debts or liabilities of such Member or his estate and any other person, whether a Member of the Company or not. The Company's lien (if any) on a share shall extend to all dividends payable thereon but the Directors may at any time declare any share to be exempt wholly or partially from the provisions of this Article. - 14 The Company may sell, in such manner as the Directors think fit, any share on which the Company has a lien, but no sale shall be made unless a sum in respect of which the lien exists is presently payable, nor until the expiration of fourteen days after a notice in writing, stating and demanding payment of the sum presently payable, and giving notice of intention to sell in default, shall have been given to the holder for the time being of the share or the person entitled by reason of his death or bankruptcy to the shares. For giving effect to any such sale, the Directors may authorize some person to transfer the shares sold to the purchaser thereof. The purchaser shall be registered as the holder of the shares comprised in such transfer, and he shall not be bound to see to the application of the purchase money, nor shall his title to the shares be affected by any irregularity or invalidity in the proceedings in reference to the sale. - 15 The net proceeds of such sale after payment of the costs of such sale shall be applied in or towards payment or satisfaction of the debt or liability in respect whereof the lien exists, so far as the same is presently payable and any residue shall (subject to a like lien for debts or liabilities not presently payable as existed upon the shares prior to the sale) be paid to the person entitled to the shares at the time of the sale. CALLS ON SHARES

- 16 The Directors may from time to time make calls upon the Members in respect of any moneys (whether on account of the amount of the shares or by way of premium) unpaid on their shares, provided that (except as otherwise fixed by the conditions of application or allotment) no call on any shares shall exceed one-fourth of the nominal amount of the share or be payable at less than fourteen days from the last call, and each Member shall (subject to receiving at least fourteen days' notice specifying the time or times and place of payment) pay to the Company at the time or times and place so specified the amount called on his shares. A call may be revoked or postponed as the Directors may determine. Calls
- 17 A call shall be deemed to have been made at the time when the resolution of the Directors authorizing the call was passed. A call may be made payable by installments. Time when made
- 18 The joint holders of a share shall be jointly and severally liable to pay all calls in respect thereof. Liability of joint holders

- 19 If a sum called in respect of a share is not paid before or on the day appointed for payment thereof, the person from whom the sum is due shall pay interest on the sum from the day appointed for payment thereof to the time of actual payment at such rate not exceeding ten per cent (10%) per annum, as the Directors may determine, but the Directors shall be at liberty to waive payment of such interest wholly or in part. - 20 Any sum which by the terms of issue of a share becomes payable upon allotment or at any fixed date, whether on account of the amount of the shares or by way of premium, shall for all the purposes of these presents be deemed to be a call duly made and payable on the date on which by the terms of issue the same becomes payable, and in case of non-payment all the relevant provisions of these presents as to payment of interest and expenses, forfeiture or otherwise shall apply as if such sum had become payable by virtue of a call duly made and notified. Sums due on allotment to be treated as calls
- 21 The Directors may from time to time make arrangements on the issue of shares for a difference between the holders of such shares in the number of calls to be paid and in the times of payment. Power to differentiate
- 22 The Directors may, if they think fit, receive from any Member willing to advance the same, all or any part of the moneys unpaid upon the shares held by him beyond the sums actually called up thereon as a payment in advance of calls and such payment in advance of calls shall extinguish, so far as the same shall extend, the liability upon the shares in respect of which it is advanced, and upon the moneys so received, or so much thereof as from time to time exceeds the amount of the calls then made upon the shares in respect of which it has been received the Company may pay interest at such rate as the Member paying such sum and the Directors agree upon. - (a) Subject to the restrictions of these presents, all transfers of shares may be effected by transfer in writing in the usual common form or in any other form in writing under hand approved by the Directors. The Directors shall also be required to approve by majority the incoming shareholder/transferor.
- (b) The instrument of transfer of a share shall be in writing and shall be signed by or on behalf of the transferor and transferee, and the transferor shall be deemed to remain the holder of the share until the name of the transferee is entered in the Register of Members in respect thereof, provided that the Directors may dispense with the execution of the instrument of transfer by the transferee in any case in which they think fit in their discretion so to do.
24. The Director may, subject to compliance with the requirements of the Act as to advertisement, suspend the registration of transfers at such time and for such periods as they may from time to time determine, but so that such registration shall not be suspended for more than Thirty days in any year.
25. All instruments of transfer which shall be registered shall be retained by the Company but any instrument of transfer which the Directors may decline to register shall on demand be returned to the person depositing it with the Company.
- The Directors may decline to recognize any instrument of transfer unless:-
- (a) Such fee, as the Directors may from time to time require, is paid to the Company in respect thereof; and
- Director's refusal to register, and closing register

- (b) The instrument of transfer is deposited at the Office or such other place as the Director may appoint, accompanied by the certificate of the shares to which it relates, and such other evidence as the Directors may reasonably require to show the right of the transferor to make the transfer.

TRANSMISSION OF SHARES

26. In case of the death of a Member the survivors or survivor where the deceased was a joint holder, and the executors or administrators of the deceased where he was a sole or only surviving holder shall be the only persons recognized by the Company as having any title to his shares; but nothing herein contained shall release the estate of a deceased holder (whether sole or joint) from any liability in respect of any share solely or jointly held by him.

27. Any person becoming entitled to a share in consequence of the death or bankruptcy of a Member may, upon such evidence as to his title being produced as may from time to time be required by the Directors, and subject as hereinafter provided, either be registered himself as holder of the share or elect to have some person nominated by him registered as the transferee thereof.

28. If the person so becoming entitled shall elect to be registered himself, he shall deliver or send to the Company a notice in writing signed by him stating that he so elects. If he shall elect to have his nominee registered, he shall testify his election by executing to his nominee a transfer of such share. All the limitations, restrictions and provisions of these presents relating to the right to transfer and the registration of transfer of shares shall be applicable to any such notice or transfer as aforesaid as if the death or bankruptcy of the

29. A person becoming entitled to a share in consequence of the death or bankruptcy of a Member shall be entitled to receive and may give a discharge for all dividends and other moneys payable in respect of the shares, but he shall not be entitled to receive notice of or to attend or vote at meetings of the Company or, save as aforesaid, to any of the rights or privileges of a Member until he shall have become a Member in respect of the share, and should he fail either to transfer the share or to elect to be registered as a Member in respect thereof within sixty days of being required so to do by the Directors, he shall in the case of shares which are fully paid up be deemed to have elected to be registered as a Member in respect thereof, and may be registered accordingly.

FORFEITURE OF SHARES

30. If a Member fails to pay the whole or any part of any call or installment of a call on the day appointed for payment thereof, the Directors may, at any time thereafter during such time as any part of such call or installment remains unpaid, serve a notice on him requiring payment of so much of the call or installment as is unpaid, serve a notice on him requiring payment of so much of the call or installment as is unpaid, together with any interest which may have accrued and all expenses which may have been incurred by the Company by reason of such non-payment.

The continuing Directors may act notwithstanding any vacancies in the Board, but if and so long as the number of Directors is reduced below the minimum number fixed by or in accordance with these presents, the continuing Directors or Director may act for the purpose of filling up vacancies in the Board or of summoning General Meetings of the Company, but not for any other purpose. If there be no Directors or Director able or willing to act, then any shareholder may summon a General Meeting of shareholders for the purpose of appointing Directors. **Proceedings in case of vacancies**
94. The Chairman of the Board shall preside at all meetings of the Members. If at any meeting the Chairman shall be not present within fifteen minutes after the time appointed for holding the same, the Directors present may choose one of their number to be Chairman of the meeting. **Chairman**
95. A resolution in writing, signed by all the Directors for the time being, shall be effective as a resolution passed at a meeting of the Directors duly convened and held, and may consist of several documents in the like form, each signed by one or more of the Directors. **Resolutions in writing**
96. A meeting of the Directors for the time being, at which a quorum is present, shall be competent to exercise all powers and discretion for the time being exercisable by the Directors. **Powers of meeting at which a quorum is present**

97. Without prejudice and in addition to the Provisions of Article 83, the Directors may delegate any of their powers to committees consisting of such number of members of their body as they think fit. Any committee so formed shall in the exercise of the powers so delegated conform to any regulations that may be imposed on them by the Directors. Power to appoint committees
98. The meetings and proceedings of any such committee, consisting of two or more members, shall be governed by the provisions of these presents regulating the meetings and proceedings of the Directors, so far as the same are applicable and are not superseded by any regulations made by the Directors under the last preceding Article. Proceedings at committee meetings
99. All acts done by any meeting of Directors, or of a committee of Directors, or by any person acting as a Director, shall as regards all persons dealing in good faith with the Company, notwithstanding that there was some defect in the appointment of any such Director, or person acting as aforesaid, or that they or any of them were disqualified, or had vacated office or were not entitled to vote, be as valid as if every such person had been duly appointed, and was qualified and had continued to be a Director and had been entitled to vote. Validity of acts of Directors in spite of some formal defect

ALTERNATE DIRECTORS

100. Any Director may at any time appoint any person approved by the Board to be an Alternate Director of the Company and may at any time remove any Alternate Director so appointed by him from office. An Alternate Director so appointed shall not be entitled to receive any remuneration from the Company or to appoint an Alternate but shall otherwise be subject to the provisions of these presents with regard to Directors. An alternate Director shall be entitled to receive notices of all meetings of the Board, and to attend and vote Provisions for appointing and removing Alternate Directors

as a Director at any such meeting at which the Director appointing him is not personally present, and generally to perform all the functions of his appointor as a Director in the absence of such appointor. An Alternate shall ipso facto cease to be an Alternate Director if his appointor ceases for any reason to be a Director. All appointments and removals of Alternate Directors shall be effected by writing under the hand of the Director making or revoking such appointment left at the office.

MINUTES

101. The Directors shall cause proper minutes to be made in books to be provided for the purpose of all appointments of officers made by the Directors, of the proceedings of all meetings of Directors and committees of Directors and of the attendances thereat, and of the proceedings of all meetings of the Company and all business transacted, resolutions passed and orders made at such meetings, and any such minute of such meetings if purporting to be signed by the Chairman of such meeting, or by the Chairman of the next succeeding meeting of the Company or Directors or committee, as the case may be, shall be sufficient evidence without any further proof of the facts therein stated.

THE SEAL

102. The Seal of the Company shall not be affixed to any instrument except by the authority of a resolution of the Board and shall be so affixed in the presence of at least one Director and the Secretary or some other person approved by the Board, both of whom shall sign every instrument to which the Seal is so affixed in their presence.



AUTHENTICATION OF DOCUMENTS

103. Any Director or the Secretary or any person appointed by the Directors for the purpose shall have power to authenticate any documents affecting the constitution of the Company (including the Memorandum and Articles of Association) and any resolutions passed by the Company or the Board, and any books, records, documents and accounts relating to the business of the Company, and to certify copies thereof or extracts therefrom as true copies or extracts, and where any books, records, documents or accounts are elsewhere than at the Office, the local manager or other officer of the Company having the custody thereof shall be deemed to be a person appointed by the Directors as aforesaid.

DIVIDENDS

104. Subject to any special rights as to dividend attached to any new class of shares in accordance with these presents, the profits of the Company available for dividend and resolved to be distributed in respect of any financial year or other period for which the Company's accounts are made up and submitted to the Company in General Meeting shall be apportioned and paid to the Members according to the amounts paid on the shares held by them respectively during any portion or portions of the period in respect of which the dividend is paid but if any share is issued on terms providing that it shall rank for dividends as from a particular date, such share shall rank for dividends accordingly.

105. No dividend shall be payable except out of the profits of the Company, or in excess of the amount recommended by the Directors.

106. Any General Meeting declaring a dividend may resolve that such dividend be paid wholly or in part by the distribution of specific assets, and in particular of paid-up shares, debentures or debenture stock of the Company, or paid-up shares, debentures or debenture stock of any other company, or in any one or more of such ways.
107. If and so far as in the opinion of the Directors the profits of the Company justify such payments, the Directors may pay to the holders of any class of shares interim dividends thereon of such amounts and on such dates as they think fit. Payment of interim dividends
108. No unpaid dividend, bonus or interest shall bear interest as against the Company. Dividends not to bear interest
