Form of Contract

This AGREEMENT (hereinafter called the "Contract") is made this ^{18th}..... day of ⁰³....., 2025 between, The Permanent Secretary, Ministry of Home Affairs, Government City – Mtumba, Habari/Afya Street, P.O. Box 2916, 40483 DODOMA of Tanzania hereinafter called the "The Employer" of the one part, and M/S. KILIMANJARO INTERNATIONAL LEATHER INDUSTRIES CO. LTD, P.O.BOX 74, MOSHI-KILIMANJARO hereinafter called the "Supplier" of the other part.

WHEREAS

- (a) The Purchaser has requested the Supplier to Supply uniform (Military Boots and Staff Shoes) as defined in the General Conditions of Contract attached to this Contract (hereinafter called the "Goods").
- (b) The Kilimanjaro International Leather Industries Co. Ltd, having represented to the Permanent Secretary, Ministry of Home Affairs that they have the required professional skills, personnel and technical resources, have agreed to supply the goods on the terms and conditions set forth in this Contract at a contract price of **Tanzania Shillings Four Hundred Forty-Eight Million Five Hundred Thousand (TZS.448,500,000.00) only VAT Inclusive.**
- (c) The Purchaser has committed funds towards eligible payments under this Contract, it being understood that such payments will be subject, in all respects, to the terms and conditions of the Contract providing for the funds and that no party other than the Purchaser shall derive any rights from the Contract providing for the funds or have any claim to the funds proceeds;

NOW THEREFORE, the parties hereto hereby agree as follows:

1. The following documents attached hereto shall be deemed to form an integral part of this Contract:
 - a) Form of Agreement;
 - b) Letter of Acceptance;
 - c) Form of Tender;
 - d) The Special Conditions of Contract;
 - e) The General Conditions of Contract;
 - f) Technical Specifications;
 - g) Statement of Requirements;
 - h) The Priced Activity Schedule;
 - i) Other relevant document(s):
 - Performance Securing Declaration
 - Power of Attorney
2. The mutual rights and obligations of the Permanent Secretary, Ministry of Home Affairs and the Kilimanjaro International Leather Industries Co. Ltd shall be as set forth in the Contract, in particular:
 - a) The Supplier shall carry out the Services in accordance with the provisions of the Contract; and

- b) The Purchaser shall make payments to the Service Provider in accordance with the provisions of the Contract.
- 3. In consideration of the payments in the sum of **Tanzania Shillings Four Hundred Forty-Eight Million Five Hundred Thousand (TZS.448,500,000.00) only VAT Inclusive** to be made by the Purchaser to the Supplier as hereinafter, the Supplier hereby covenants with the Purchaser to **Supply uniform (Military Boots and Staff Shoes)** and remedy any defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Purchaser hereby covenants to pay the Supplier in consideration of **Supply uniform (Military Boots and Staff Shoes)** and the remedying of defects wherein the amount of **Tanzania Shillings Four Hundred Forty-Eight Million Five Hundred Thousand (TZS.448,500,000.00) only VAT Inclusive** (herein called "Contract Price") or such other sum as may become payable under the supply of the Contract at the times and in the manner prescribed by the Contract.
