INTRODUCTION:

TANGBEN STONES INVESTMENT COMPANY LIMITED is a Limited liability Company duly incorporated and existing under the Companies Act Cap. 212 (RE) 2002 of the Laws of Tanzania with Registration Number **183353136** and of Postal Office Box Number 2020 Geita dealing with Stone Quarrying and Aggregates Production, the Project which is located at Ibanda Village, Kasamwa Ward, Geita District with in Geita Region, Tanzania.

PRESENT MANAGEMENT AND LEGALITY OF THE BUSINESS

XIAO HAITANG and **BENARD REUBEN SHIGELA** are current Directors and owners of the Company (**TANGBEN STONES INVESTMENT COMPANY LIMITED**), they are all responsible for decision making concerning the business management.

The business is legally registered under Tanzania Laws with Registration Number **183353136** and Taxpayer Identification Number (TIN) **183353136**.

ACTIVITIES OF THE PROJECT

The project is basically dealing with providing a technical support in terms of technology expatriates and finance in stone quarrying and aggregates production to the License Owner known as **EMMANUEL FRANCIS JILABI** with respect to the Primary Mining License (PML) number **02299 GTA**.

PROJECT DESCRIPTION

TANGBEN STONES INVESTMENT COMPANY LIMITED holds multiple Primary Mining Licenses (PMLs) in mineral-abundant zones within Geita Region and aims to achieve an annual production capacity of 800,000 metric tons of various aggregates, addressing the increasing demand within Tanzania's construction industry.

The project is strategically located approximately **120 km** from Mwanza, along the Lake Victoria basin, and will leverage state-of-the-art imported equipment to ensure superior-quality products compliant with Tanzanian Bureau of Standards (TBS) criteria.

PROJECT INVESTMENT CAPITAL

The total initial investment for the project is **USD 4,270,000 Million**, including:-
