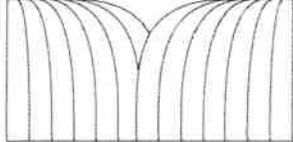

APPLICATION FOR EXPANSION OF THE CERTIFICATE OF INCENTIVES IN TERMS OF SECTION 19 OF THE TANZANIA INVESTMENT ACT, 2022 AND REGULATION 20 OF THE INVESTMENT REGULATIONS, 2023
