LEASE AGREEMENT

THIS AGREEMENT is made on this 26th day of August, 2025

BETWEEN

KWACHAGA VILLAGE COUNCIL of P. O. Box 355, Handeni (herein after referred to as "the Lessor" which expression shall where the context so admits include its successors and assigns) of the first part.

AND

MISRILALL RESOURCES PVT LTD of P. O. Box 24468. Incorporated and carrying business in Tanzania, having a TIN. No. 159281639 having registered office at NHC House, 4th floor, Samora Avenue, Dar Es Salaam, Tanzania. (herein after referred to as "the Lessee" which expression shall where the context so admits include its successors and assigns) of the second part.

WHEREAS:

- A. The Lessor is the local government authority established under the Local Government (District Authorities) Act, Cap. 287 with the responsibility of promoting development and welfare of Kwachaga community and a lawful owner of four and half (4.5) acres of land situated at Mwareni area within Kwachaga Village, Kwachaga Ward within Handeni District where on Northern side it is boarded with a road from Kwachaga Village to Lyagaya Village, Southern side bordered with Kwachaga Village forest/area, Eastern side Kwachaga Village forest/area,

Western side Kwachaga Village forest/area (herein after referred to as "the demised property");

- B. The Lessee is registered under Cap. 212 of the laws of Tanzania and therefore desirous of leasing the said land from the Lessor pursuant to the herein after terms;
- C. The Lessee is desirous of building a Graphite Processing Plant on the leased land.

WHEREFORE in consideration of the following covenants and agreements, the Parties agree as follows:

1. That, the Lessor leases to the Lessee, upon the terms and condition contained herein, the land measured four and half (4.5) acres situated at at Mwareni area within Kwachaga Village, Kwachaga Ward within Handeni District for the period of 15 years commencing on the 26th /08/2025 until the 26th /08/2040, subject to automatic renewal for further 15yeras on mutual consent without any objection from lessor represented by the chairperson of the Kwachaga Village Council
2. The Lessee to pay the Lessor a monthly rent of Tanzanian Shillings 250,000 (TZS 250,000/-), such payments to be made in quarterly by the 15th day of the month immediately following the end of each quarter (e.g ., january 15th for Oct - Dec quarter) to the Lessor's account, held in the name of MIRADI YA MARENDELEO KWACHAGA at NMB Bank (Account No: 41410009486). The monthly rental amount is fixed for the initial lease term of 15 years and be revised thereafter by the mutual consent
3. That, the Lessee undertakes to erect Graphite Processing Plant as per the statutory guidelines of Tanzanian Government.
4. Lessee shall disburse a one-time community facilitation fee of 1,300,000/- TZS (One Million Three Hundred Thousand Tanzanian Shillings) to all 26 members of the land of the Kwachaga Village on receiving the list of the 26 members duly signed by the chairperson of the Kwachaga Village Council and all the 26 members will give officially signed receipts of the payment received. The amount of 1,300,000 TZS will be given at the time of signing of the agreement. This payment supports administrative costs associated with the lease.

5. Lessee shall construct a borewell for providing drinking water distribution to Kwachaga Village, the maintenance obligations of the borewell will be of Kwachaga Village Council.
6. Lessee shall give preference on hiring qualified residents of Kwachaga Village for operational roles, adhering to skills-based recruitment as and when required by the plant.
7. Lessee shall fund the repairs of Kwachaga Primary School's flooring and renovate the primary school toilet within 12 months on successful commencement of the production in the plant.
8. Upon the Plant achieving 100% production capacity for 3 consecutive months, Lessee shall financially assist forth upcoming Higher Secondary School upon mutual discussion and joint approval by both parties.
9. Automatic Lease Renewal of the land allotted to Lessee beyond 15 years if required by Lessee, without any objection from lessor represented by the chairperson of the Kwachaga Village Council.
10. All payments shall be receipted and recorded. This Agreement constitutes the entire understanding between Parties. The Kwachaga village council covenants that no further monetary or non-monetary demands shall be made against Lessee.
11. That, the Lessee undertakes to accept the demised property in its current condition pursuant to the intended purpose with restriction not to assign the same, nor subletting any portion thereof without the prior written consent of the Lessor.
12. That, notwithstanding the forgoing, the Lessee shall not use the demised property for the purposes of storing, manufacturing or selling any explosives.
13. That, the Lessor shall set the demised property free from any encumbrances before the commencement of this agreement.
14. That, the Lessor covenants that the Lessee shall have, hold and enjoy the demised property for the term hereof, subject to the conditions set forth herein.

15. That, this Agreement terminates and supersedes all prior understandings or agreements on the subject matter. This Agreement may be modified only by a further writing that is duly executed by both parties.

16. That, this agreement shall be governed and construed in accordance with the laws of Tanzania.

17. That, in the event of any dispute, the same shall be settled through non-judicial procedure that is amicably and negotiations between the parties and in case of dissatisfaction, either party may refer the grievance before domestic court of competent jurisdiction. All formal notices shall be in writing and shall be addressed to the parties at their official address.

18. In the event the Plant becomes uneconomical to operate or due to a Force Majeure event, the Lessee shall have the right to terminate this Lease Agreement immediately by dismantling and removing its Plant and machinery from the leased land. The Kwachaga Villagers and Kwachaga Village Council shall raise no objection to such removal. Upon completion of the removal, this Lease shall be terminated with immediate effect, and the Company shall be released from any and all future liabilities arising from or related to this Agreement

19. Force majeure shall include, be restricted to, contingencies caused by neither of the parties herein and unforced in occurrence such as act of GOD, act of Nature, acts and incidents of War, Fire, Civil Unrest, Government.

The Village Chairman opened the meeting at 2:30 p.m., thanking the members who attended and asking them to fully deliberate on the meeting's agenda.

The Secretary read the resolutions relating to matter arising in Village Council meeting regarding receiving and approving the investor Misrilall Resources Pvt Ltd.


AGENDA NUMBER 2: DELIBERATION ON, AND INVESTOR APPROVAL

After thorough discussions and deliberation, investor Misrilall Resources Pvt Ltd was approved by all members of the General Assembly.

General Assembly had further laid down conditions which were agreed by the investor Misrilall Resources Pvt Ltd.

That the Agreements between Kwachaga Village and investor Misrilall Resources Pvt Ltd are as follows:

1. **Water infrastructure** – Investor Misrilall Resources Pvt Ltd shall construct a borehole for the supply of drinking water to Kwachaga Village. Maintenance of the borehole shall remain the responsibility of the Kwachaga Village Government.
2. **Employment preference** – The investor Misrilall Resources Pvt Ltd shall give priority to qualified residents of Kwachaga Village for operational jobs, considering the skills required by the plant.
3. **Primary school renovation** – The investor Misrilall Resources Pvt Ltd shall finance the repairs of Kwachaga Primary School's flooring and renovate the school toilet, within 12 months of successful commencement of production of plant.
4. **Education support fund** – After the plant has achieved 100% production capacity for three consecutive months, the investor Misrilall Resources Pvt Ltd shall provide financial support

to the upcoming secondary school upon mutual discussion and joint approval between the investor Misrilall Resources Pvt Ltd and Kwachaga Village Government.

5. Lease renewal and rental payments –


- 5.1. There shall be a Irrevocable 15years lease agreement between the investor Misrilall Resources Pvt Ltd and Kwachaga Village for the allocated 4.5-acre land.
- 5.2. The investor shall pay TZS 250,000 monthly lease rent to the Kwachaga Village council, this monthly leasing rent will be paid on quarterly basis by 15th day of the month immediately following the end of each quarter deposited into NMB Bank account: *Miradi ya Maendeleo Kwachaga, Account No. 41410009486.*
- 5.3. This rent shall remain fixed for the first 15 years and may be revised thereafter by mutual agreement.
- 5.4. Automatic renewal of the lease of land allocated to Misrilall Resources Pvt Ltd more than 15years if required By Misrilall Resources Pvt Ltd without any objection from the villager represented by the chairman of Kwachaga Village
- 5.5. The investor Misrilall Resources Pvt Ltd shall also make a one-time community facilitation fee of TZS 1.3 million to all 26 members of the land of Kwachaga Village, after receiving the list of the 26 members signed by Kwachaga Village Council Chairman. Official signed receipts shall be issued for such payments. The amount of 1,300,000 TZS will be given at the time of signing of the agreement.
- 5.6. Costs of land surveying and securing the land title deed shall be borne by the investor Misrilall Resources Pvt Ltd.




