**RE: REQUEST FOR EXTENSION OF INCENTIVE PERIOD FOR NEW PROJECT AT

We would like to inform your office that, following your guidance, we are submitting this letter to request for the extension of the incentive period in respect of our new poultry project currently under construction at Chamakweza Village, Plot Numbers 3–10, Block 18 K, Chalinze District Council.
