**THIS AGREEMENT** is made this 19<sup>th</sup> day of July 2025

**BETWEEN**

**NANU ATHUMANI MACHAKU** of NIDA NO: 19680828-61314-00001-28, Mbala Ward [hereinafter referred to as "**the Vendor**" the expression which shall, where the contents so permit, include its assigns and successors in title] of the ONE PART.

**AND**

**HUATONG LOGISTICS LIMITED** of P.O. Box 31299, Dar es Salaam a limited company duly registered under the Laws of the United Republic of Tanzania [hereinafter referred to as "**the Purchaser**" the expression which shall, where the contents so permit, include its assigns and successors in title] of the OTHER PART.

**WHEREAS:**

- A. The Vendor is a lawful owner of the parcel of land described as **PLOT NO: 5 BLOCK "18A"** located at **CHAMAKWEZA, CHALINZE DISTRICT COUNCIL, PWANI** measuring **89,414 (SQM)** described under registered Survey Plan No: PWNSP00001289.
- B. The Vendor is desirous of selling and the purchaser is desirous of buying the said parcel of land at a consideration of **Tanzanian Shillings Seventy Million (Tshs 70,000,000/=) only** on terms and conditions hereinafter appearing.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS: -**

1. The Vendor shall sell and the Purchaser shall buy the said parcel of land subject to the covenants hereinafter stipulated otherwise free from all encumbrances whatsoever at the price aforementioned.
2. That Vendor and Vendor and the Purchaser have agreed that the Purchase Price shall be paid in cash single installment.

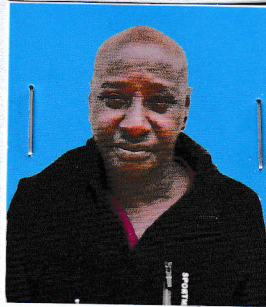
- i) At the date of signing of this agreement the purchaser shall pay the vendor the whole of **Tanzanian Shillings Seventy Million (Tshs 70,000,000/=) only.**
3. That by signing this agreement the Vendor and Purchaser agreed mode of payments stipulated herein above in clause (2) in this agreement.
  4. That upon receipts of full payment of the Purchase price as specified in clause 2 herein above the Vendor shall formally handover the property to the Purchaser and avail to the Purchaser all relevant documents in respect of the property.
  5. Simultaneous with the execution of this agreement the Purchaser will assume ownership of the property from the date of execution of this agreement subject to receipts of the full payment of purchase price.
  6. That this Agreement is subject to consent of the Commissioner for Lands/ Authorized Officer on conveyance the said plot from the Vendor to the Purchaser and in the event that the consent is withheld, the agreement shall be null and void and parties shall revert to their original position.
  7. That this Agreement emanate transfer of the said property shall be subject to the approval of the Commissioner for Lands or other officers duly authorized on that behalf accorded to this disposition and in the event of such approval being refused the parties shall revert to their original position and any money paid by the purchaser shall be refunded to him by the vendor.
  8. Purchaser shall bear all legal fees, stamp duties, approval fees, registration fees and other disbursements arising out of and in connection or incidental to the preparation and completion of the Agreement.

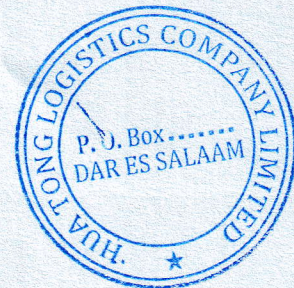
