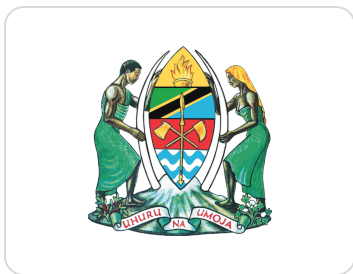

Rejection of project registration by the Authority (Mamlaka) entails different dimensions and normally focuses on the public interest including protection of jobs for locals to a specified projects, capital accruals for locals, re-investments, multiplier investment to other locals e.t.c. Cargo transportation project is among of the project which doesn't need heavy machinery to initiate and in fact no directly value addition is maintained apart from job creation and importation of goods. Authority is also looking at the influx of road trucks which doesn't go hand in hand with expansion of the existing /newly established roads countrywide. The government priority now is to strengthen railway roads including SGR for easy cargo transportation from the centre to the peripherals. In this aspect more investment opportunities are available for establishing logistical hubs along SGR and borders (Kigoma, Mbeya Namanga etc) and those are among of the viable projects to undertake by foreign investors.

In this aspect, it not a matter of employment creation and inviting local partners to collaborate with. We don't force foreign investors to have locals who have nothing to contribute in the project to be a shareholder. In fact, this is not right, investment is about someone's money who has been

saved/accumulated for a long time!
